The renter understands that it is their responsibility to **charge the batteries** for the equipment before, during and **after** use. Kelowna Film Society and Leo's Videos *does not guarantee* that the batteries have been fully charged at the beginning of the rental period.

In addition, it is the renter's sole responsibility to **erase their data** from the memory unit and it **MUST** be returned blank.

I, the Renter will assume full responsibility for the equipment during the rental period and I will ensure that only qualified persons use the equipment. Furthermore I agree that the proper operation of the equipment is my responsibility and do not expect Kelowna Film Society or Leo's videos to instruct me in any way as to the proper use of the equipment.

I agree to immediately notify Leo's Videos of any loss or damage to the equipment during my rental period. I understand that the equipment will be inspected upon its return and I, the renter, shall be fully responsible and PAY for any loss or damages to the equipment incurred during my rental period, (however caused) including, if applicable, any insurance deductible. In addition the renter agrees to pay the full daily rental rate for any time that the camera is undergoing repairs that were incurred during his/her rental period.

The renter agrees that it shall use the equipment at its own risk and hereby agrees to indemnify and hold Kelowna Film Society and Leo's Videos harmless for any and all liability, loss, damage, expense, cause of action, suits, claims or judgments arising from or in connection with the actual use, operations, transportation or availability of the equipment.

In addition, Kelowna Film Society and Leo's Videos is not responsible for any time or financial losses to the renter due to faulty equipment, non-performance or inconsistent performance of the equipment or operation thereof.

Furthermore, Kelowna Film Society and/or Leo's Videos is not responsible for any loss or damage to material recorded with the equipment. It is the Renter's sole responsibility to save and properly download their recorded material *before* returning the equipment.

The Renter agrees that if the equipment is returned in an unclean state or with un-charged batteries, or with data on the memory, the Renter will pay an additional \$25.00 for each of the above occurrences.

The Renter agrees that it will return the equipment by 11:00 am on the agreed upon return date or will PAY an additional day's rental fees and FORFIET future privileges to rent the gear.

The Renter agrees that if credits are a part of the finished project, renter will supply a "thanks to Kelowna Film Society" credit.

The renter agrees that he/she will notify Kelowna Film Society via camera@kelownafilm.com if the gear is to be used outside of the Okanagan area. Note: you will not necessarily be denied use of the camera outside of the Okanagan, however we do need to know about it to appraise our insurer.

The renter (or credit card holder) agrees that the damage deposit and the following credit card will be charged, for any loss or damage to the equipment, or for late return, uncharged batteries, etc etc. as above.
